1 PURPOSE OF THIS NOTICE

We respect the privacy of every person who accesses the Performance Zone or the Members Club website together the “**Platform**”. This privacy notice explains our approach to any personal information that you might supply to us (or that might be collected from you) in connection with your use of the Platform.

The Platform is intended for use by organisations and your access to this Platform has been granted by the organisation you work for. We are therefore providing you access to the Platform acting on behalf of your organisation and your organisation will have the right to: (i) control and administer your access to the Platform; and (ii) access and process any data you submit or provide through use of the Platform.

Accordingly, your organisation is likely to have its own policies regarding storage, access, modification, deletion and retention of personal information you submit or provide through your use of the Platform.

4 WHAT PERSONAL INFORMATION WE COLLECT AND HOW WE COLLECT IT

We collect and maintain personal information that you voluntarily submit to us during your use of the Platform (e.g. when registering with us, when inputting any information into the Platform, during the course of email exchanges with us or as part of any customer support interactions).

In particular, in order to register with and gain access to the Platform, we require the following personal information from you:

- First name;
- Last name;
- Email address;
- Contact telephone number.

For some Performance Zone programmes, we may also collect the following personal information from you:

- Postal address;
- Any personal information that you volunteer about yourself in response to our initial fact-finding questionnaires.

If you contact us, we may collect additional personal information from you such as your opinion of our service.

We may also combine personal information that we collect through your use of the Platform with personal information that you have provided to third parties (e.g. your employer) and in respect of which you have given the third party permission to share with us. We may also collect personal information regarding your use of and activity on the Platform through use of cookies. This personal information allows us to deliver more helpful information and services and improve the Platform.

Cookies

Through our use of cookies, log files and other similar technologies, we may collect personal information regarding your mobile device or the computer hardware and software used to access the Platform. This may include the following:

- IP address of device(s) used;
- Browser type and language;
- Operating system and device type;
- Referring website addresses or exit website addresses;
- Approximate location;
- Access times and dates;
- Information relating to your interaction with videos on the Platform (video titles watched, IP address per video, date/time of video viewed, number videos viewed).

What are cookies?

A cookie is a very small text document, which often includes an anonymous unique identifier. Information gathered through cookies may include the date and time of the visits made to the Platform, the pages viewed and the time spent on the Platform. What cookies do we use?

We use a range of cookies on the Platform. These are used to enable us to recognise you when you log in and to help make it easier for you to navigate the Platform. We also use “analytics” cookies which, in conjunction with our web server’s log files, allow us to calculate the aggregate number of people visiting our Platform and which parts of our Platform are most popular. This helps us gather feedback so that we can improve the Platform and better serve our users. We do not generally store any personal information that you provide to us in a cookie.

You can find more information about the individual cookies we use and the purposes for which they are used in the table below:

Cookie Type	Purpose
JSESSIONID	Enables you to carry information across pages of the Platform and avoid having to re-enter information. Session cookies enable us to compile statistics that help us to understand how the Platform is being used and to improve its structure.
login	Encrypted account identifier for automatic login to the Platform.
productView	Remember the setting for search result view.

quality	Remembers the preferred video quality when not using adaptive bitrate.
video.useBackup	Remember your choice to use video fall-back version when primary version can't be played.
Google Analytics _ga _gid _gat	Allows us to store information such as the time you visit the Website, whether you have visited before and the website that you visited prior to visiting our Website. Most of our cookies expire within 30 days, although some such as analytics cookies, may persist for between two and ten years.

5 HOW WE USE YOUR PERSONAL INFORMATION

Provision of the Platform

We use your personal information to administer your account on the Platform, to process your responses to our surveys and information requests to help us make the Platform more relevant to you, to provide you with access to the Platform and the content on the Platform and to carry out actions you request on the Platform, such as requests for support.

Communicating with you

We use your personal information to communicate with you by email and telephone. We may send you service messages and links by email to content to which you have been subscribed, or we may speak to you by telephone about the administration of your account and any queries you may have.

Feedback

We may offer various user interfaces to allow visitors to provide us with feedback about the Platform. Contact information may be requested in each case, along with information about your computing environment and/or industry, and details of your request or reported feedback. This information is used in order to allow us to respond to your requests, to assure that the Platform and any other services work correctly.

Usage reports

We create usage reports which incorporate information about the use of the Platform by you and other users. Such information will be aggregated and anonymised. These reports may be used for marketing purposes.

Sharing information with your organisation

If requested by your employer or organisation, we will share your personal information with them. For example, we will share usage reports with your employer or organisation, setting out which videos have been watched by whom. This information will not be anonymised.

6 TRANSFERS OUTSIDE THE EEA

We share your personal information with a variety of third party service providers to assist us with the operation and management of the Platform. These providers include payment processors, survey providers, software providers and helpdesk support.

Some of our third party service providers are located in the USA. All of our third party processors who are located in the USA are registered as active participants in the EU-U.S. Privacy Shield. However, for the purpose of transferring your personal information to them, we intend to rely on EU approved standard contractual clauses which ensures your personal information is subject to a similar level of protection it has in Europe.
